Kirk Leopard has been named the first director of Miramar National Cemetery and has been the director of Fort Rosecrans National Cemetery since November 2007. The new 313 acre national cemetery located at the northwest corner of Marine Corps Air Station Miramar will serve Veterans' needs well into the 21st century. Mr Leopard has served as the director of Baltimore National Cemetery in Maryland and assistant to the director at Fort Mitchell (Alabama) National Cemetery. He retired from the Navy in 2004 after 21 years of service. He will speak at the April Joint Chapter/Navy League dinner and cover VA burial benefits provided at national cemeteries. Fort Rosecrans closed to first interment casketed burials in 1966, although it stays active with casketed interments of family members of those already interred and inurnments of cremated remains. Miramar National Cemetery will include both gravesite and columbarium development, providing a full range of burial alternatives to approximately 235,000 Veterans in the San Diego County area.

Legislative Update

Jones Files SBP-DIC Discharge Petition On March 15, Rep. Walter Jones (R-NC) introduced a [discharge petition](#) on the House SBP-DIC offset repeal bill, H.R. 775. This relatively rare tactic is used to force a House vote on legislation that has languished in committee.

The petition offers hope that Congress will finally repeal the unfair deduction of VA Dependency and Indemnity Compensation (DIC) from military widows' Survivor Benefit Plan (SBP) annuities.

It was a discharge petition that helped break the ice in winning substantive action on concurrent receipt several years ago.

H.R. 775, sponsored by Rep. Solomon Ortiz (D-TX) currently has 320 plus co-sponsors - 74% of all House members. If more than half of House members (216) sign the petition, the bill must be "discharged" from committee consideration and brought to the floor for a vote. Rep. Ortiz' office staff has advised MOAA that he intends to sign it.

You would think that getting at least 216 of the 320 plus current cosponsors to sign the petition would be no problem. But it hasn't proved that easy in the past.

That's because a discharge petition is an embarrassing move for congressional leaders who are responsible for finding funds to pay for it. In this case, the SBP-DIC fix requires \$7B in mandatory spending that Armed Services Committee leaders don't have offsets for.

Normal House rules require that the responsible committee must identify offsets within its jurisdiction. For the Armed Services Committee, that would require cutting military retirement, TRICARE for Life or some other SBP area, which isn't going to happen. Committee leaders want to repeal SBP-DIC, but doing that requires House leadership's help to identify other offsets. And that's a problem too, when national health reform and other major initiatives are consuming most of the available offsets.

MOAA agrees with Rep. Jones that it sometimes takes

unusual action like a discharge petition to spotlight a bill that has a very large majority of cosponsors but still isn't getting anywhere, for whatever reason. The discharge petition is a way of saying, "We need to put our money where our mouth is."

MOAA, Coalition Push FY11 Priorities MOAA joined a panel of Military Coalition witnesses at a March 24 hearing before the House Armed Services Military Personnel Subcommittee.

The hearing was convened specifically to get inputs from beneficiary advocates on issues affecting active duty, Guard/Reserve, retired members, families and survivors.

Among many other inputs, the Coalition witnesses particularly urged the Subcommittee to:

- Provide at least a modest increase above the 1.4% pay raise proposed by the Pentagon, in the belief that troops being asked to endure more sacrifice than at any time in the last 50 years shouldn't be provided the lowest pay raise in almost 50 years
- Approve the Administration's proposal to authorize concurrent receipt for all medically retired servicemembers, with the continuing goal of ending the unfair disability offset for all disabled retirees
- End deduction of VA survivor benefits from Survivor Benefit Plan (SBP) annuities for survivors of members whose deaths were caused by service

Two Gold Star Wives representatives provided particularly compelling testimony on the SBP-DIC issue. "An 85-year-old widow shouldn't have to start dating and remarry to have SBP restored," said Mrs. Suzanne Stark. "It's discouraging to hear, year after year, 'We support you in principle, but just can't find the money'," added Mrs. Margaret McCloud.

The best way you can divert that pressure is by watching for alerts from National MOAA, responding when asked to contact our legislators, and by remaining a member of both National MOAA and the Silver Strand Chapter.

I firmly believe that your membership in both of these organizations is more important than ever right now! Legislators know that we vote and that we influence the vote of our family members and neighbors. If you haven't renewed your membership, I'd urge you to do it right now. We can best counter the pressure that's sure to come by demonstrating that our membership numbers make us a force to be considered when they are getting ready to vote.

National Health Reform and You - From the Office of The President of MOAA

Dear MOAA Member,

In recent days, we've seen a barrage of information (and misinformation, in many cases) about how national health reform legislation might affect currently serving and retired servicemembers and their families.

Now that President Obama has signed the initial legislation into law, I want to lay out for you what we know.

The biggest question on our members' minds has been: "How will passage of national health reform legislation affect me?" For members under age 65, based on what we know so far, the answer appears to be, "Not much, if at all."

There are some changes to Medicare, but it remains to be seen what the real impact of those may be over time. The most significant of them is likely to be some reduction of availability of Medicare Advantage HMOs.

In the meantime, MOAA has prepared [answers to the most-frequently asked questions](#) that we hope you'll find useful.

Unfortunately, there already are messages flying around the internet to the effect that "I heard this will end TRICARE" or "This will force military people to buy other coverage." That's simply not true. If you get such messages, please help educate the senders with MOAA's answers.

As MOAA has said from the beginning, everyone we've talked to in the Administration or the House or the Senate, of either political party, supports protecting military and VA beneficiaries from adverse effects associated with national health reform.

Just to be sure, MOAA and loyal members like you generated more than 100,000 messages to Congress urging protection of the unique military and VA health benefits and protection against any taxation of those benefits. And your voices were heard.

In as clear an indication of that as anyone could ask for, the House unanimously passed separate legislation explicitly citing TRICARE as "qualifying health coverage" for purposes of the new law. The Senate is working now to pass the same legislation. VA care and TRICARE For Life already were explicitly designated in law. That means eligible beneficiaries of those programs won't be subject to financial penalties that can be imposed on people who don't have qualifying insurance.

That said, let's be clear on another key issue.

Can anyone guarantee that there will never be any unfavorable changes to military and VA programs? No.

Do we know for sure how all the details will play out? No.


There's always a potential for unintended consequences, and there's always the potential for new initiatives to arise (see below).

But if you were worried that national health reform legislation is somehow aimed at whacking military beneficiaries' health coverage, that's just not so.

Frankly, we think the much more significant issue for Medicare – and for the military community and the rest of America -- is what proposed changes will be recommended by the new National Commission on Fiscal Responsibility and Reform that's supposed to report by Dec. 1 on options to reduce the national debt.

You have my personal pledge that MOAA will continue to be vigilant as implementation of national health reform proceeds – and as the new debt commission proposals become known – and your association will continue to do everything in our power to protect your interests and your service-earned health benefits.

VOLUNTEERS NEEDED! NAVY'S RETIRED ACTIVITIES PROGRAM

Retired Activities Offices (RAOs) serve as link between local retirees and the military community, as well as other governmental agencies that provide assistance to retirees. RAOs are often located on Navy and Marine Corps Installations and are staffed, in most cases, with retiree volunteers who will assist other retirees, their family members, and survivors directly, or guide them to organizations to ensure they receive services and benefits to which they are entitled. RAOs often coordinate with Fleet & Family Service Centers and assist in the Annual Retiree Seminar.

The RAO at Naval Base Coronado is co-located at the Naval Amphibious Base with the Navy's I.D. card and Personnel Offices. We welcome walk-in clients, phone calls, and e-mails to our office. The office is staffed entirely by volunteers, and we are open for business between 0900 and 1200 Monday through Friday. We are closed on federal holidays. We welcome new volunteers and provide training which many consider personally valuable. Our phone number and address are provided below. RAO tasks include:

- Provide Survivor's Benefit Plan (SBP) counseling to future and retired retirees.
- Provide Retired Casualty Assistance Program (RCAP) assistance to survivors.
- Provide assistance to retirees and/or annuitants in retired pay, annuitant pay, direct deposit and tax withholding.
- Disseminate information on new programs and benefits.
- Provide information on existing programs, rights, and benefits when requested.
- Provide assistance to resolve conflicts between retirees and various government agencies.
- Find resources to resolve retiree questions/concerns outside our expertise/purview.
- Provide location/addresses and phone numbers of various federal/state/local agencies or officials when requested.
